1. Conditions of participation for the "ROBOT line"

You can promote a **maximum of 2 industrial cleaning robots**.

Participation Requirements:

- 1. Company Profile:** International manufacturers or distributors of industrial cleaning robots and cobots, including but not limited to vacuum cleaners, sweepers, scrubbers, and robots specialized in cleaning tasks.
- 2. Innovation:** Submitted products must incorporate advanced technologies such as 3D sensors, autonomous navigation algorithms, or sustainable solutions that reduce water and energy consumption.
- 3. Safety:** Robots must comply with current safety regulations and be certified for use in industrial environments.

2. "ROBOT line" operation during Hygienalia

Each exhibitor may present a maximum of **2 robots**.

The robots will be displayed in a dedicated exhibition area, accompanied by an **informational sign** describing the product and indicating the **stand number** of the presenting exhibitor.

Each company will carry out **3 demonstrations**, one per day, according to the schedule established by the **Organizing Committee**.
